
Charity

Bringing hospital-level care to you by land and air anywhere in Berkshire, Oxfordshire and Buckinghamshire, their team are highly trained and ready for any eventuality. Giving you the best chance when the worst happens. The other being the Thin Blue Paw Foundation, who are a national dog welfare charity which protects, celebrates, supports and rehabilitates both serving and retired police dogs from across the UK. Police dogs dedicate years to serving their communities and helping fight crime. Once retired, police dogs do not receive a pension or any other financial support from the government or the police force they served with, meaning that the responsibility for their care and the cost of their vet bills falls solely on their ex-handler or new owner. They ensure all retired police dogs across the UK have access to support when they needed it.

A few words from Barbara Kuen:

Kennet Open and Intermediate Test held at East Garston on Saturday 29th March.

Four tests were organised for the Day. The Open Dogs and the Intermediate Dogs ran the same course with the Intermediate competitors taking the tests at a shorter distance.

The first test for Florrie (Int) Affie (Open) and I was with Jill Gardner. This was a four dog walk up with memory mark retrieves in front of the line and retrieves behind. The memory mark was lost over a brow so although not overlong, nonetheless proving tricky.

We moved on to see Bob Marcham who was judging a long double mark just into woodland. It was long for the Intermediate and for the Open tricky as the fall of the dummy could barely be seen. However, the dogs enjoyed the length and were obviously pleased with being stretched.

Onwards to see Sue Berman. Here we faced a long blind retrieve at a 45 degree angle to us. The dummy was placed up in front of a hedge line taking the dogs over white and assorted grasses. On the dog's return, a shot was fired and a distraction thrown. If the dog didn't acknowledge the shot or mark the fall, this too became a blind. My own Intermediate dog didn't mark it but my Open dog caught site of it and made a neat job. Handler well chuffed!

Lastly off to see Pete Castleman. Here we faced a double blind. First retrieve over a slight brow with a fallen branch and bedecked by close woodland. It was easy to lose sight of the dog and there didn't appear to be much scent coming off the dummy. Upon the dog's return, we were turned 90 degrees for a blind up a hill towards disused cover crop. Again, very easy to lose the dog into the wood, and testing for both grades.



All tests complete. Wiped brow, because we were fortunate not to pick up a zero during the day and so back for tea to await results. I was delighted to learn that I came first in the Intermediate and then completely taken aback when awarded first in the Open also. All in all a 'good day at the office'!

Well done Team Kennet. A tremendous day and they made super use of this terrific ground.

A few words from Kerry Wallis:

The KVGTS Novice test at Lord Benyon's Englefield Estate was our first Novice competition of the season. After some success in Puppy the previous year, we'd aged out and moved up.

Our first test was a four-dog walk-up—our first at this level, having only competed in two-dog walk-ups previously. The challenge lay in the positioning: the mark was off to the right, requiring us to turn the dogs at the shot and send them into an area of grass reeds. Wilf handled it well.

The water test was cleverly designed—a short mark onto water, followed by a blind taken first alongside the water up a track. Though it sounded straightforward, we were sending from a setback position in thin woodland, meaning the dogs needed a good line to hit the track at the right point. Added pressure: the judge was Wilf's breeder. Fortunately, we didn't embarrass ourselves!

The third test was a double blind up a hill with no shot. Both distances were long. The first required some handling, but Wilf went straight to the second, which pleased me—reports suggested many struggled there. Our final test featured a long mark straight up the field, followed by a blind through a gap in the hedge to the

right. The mark went smoothly, but the gap had proven tricky for many competitors. I knew accuracy was crucial if we were to navigate it cleanly. Wilf responded well and delivered the difficult blind.

It was an excellent day—great company, weather, tests, and judges. At the end, a runoff was announced. I was delighted just to be in contention for an award, but absolutely thrilled when Wilf was announced the winner—perfect icing on the cake. Thanks to the KVGTS, judges, and landowner for the fantastic ground.



A few words from Lesley Scutter:

Kennet's annual walked up test day judged on Field Trial lines fell on an extremely hot day. Scent was fair in the morning but as the day wore on and conditions dried even more, it seemed to disappear. Our Judges John Stubbs and Colin Pelham were very fair in the assessment of the dogs work.

Running in the Novice in the morning we lined out with a judge either side of the valley, retrieves in front to start soon became across the line retrieves as the judges worked through the rounds. Some dogs struggled with the lack of scent in the marshy grass either side of the ditch, there were opportunities for 'runners' and eyewipes. The retrieves co ordinated by Steward of the Beat Barbara Kuen resembled as closely as possible situations that would occur at a trial. The judges took six dogs forward to a drive which became even more like the real thing when the first two dogs to try flushed the real thing, poults which had been tucked up in some marshy grass. The last retrieves were in or over a ditch which again was a very realistic shoot situation.

To win with Billy aka Cornwood Glorious Twelfth was very poignant, our first two labradors, the start of our line and resulting in Billy were both Stratfield Saye bred dogs.



Inter-Counties Team Event

On Saturday 19th April held at Osberton estate organised by Dukeries Gundog Club.

What an amazing day and the running of the event was seamless. There were 5 tests, and each test really stretched the handlers and the dogs.



Test 1 judged by Dave Field

This was a Walk-up exercise. After a long slow walk Dog C had a long mark in front which was picked quickly. We then walked on and dog A was sent left-handed through a dyke and across cultivated ground to a marker flag, the dummy was within a 5-meter radius of the flag, the dog made the distance and worked the wind to locate the dummy. Walk on again and dog B had a mark in front which was nicely executed. Walked on again and dog C was sent right through some rushes to a flag and again the dummy was with a 5-meter radius of the flag, the dog handled well and quickly picked. We then walked on again, dog A had a straight mark in front. We then walked on again and dog B was sent left-handed through a dyke and across cultivated ground to a marker flag, the dummy was within a 5-meter radius of the flag, the dog handled well and quickly picked. Once the retrieving aspect of the exercise was complete, we then turned around and had to heel all the way back to the starting point.

Test 2 judged by Geoff Dobb

This was a static exercise. We stood in our allocated positions and were told that there would be a shot and mark in front, a shot and mark to the left and a shot and blind to the right. We had to mark everything as at this point we did not know which retrieve was going to be allocated to which handler. Dog B was sent for the mark straight in front into the wood land. The dog got straight to the area and worked the wind to pick. Dog C was sent for the blind retrieve to the right. The dog took a lovely line straight across the pond which was hidden from view by the undulating ground and picked with minimal handling. Dog A was then sent for the long mark to the left. The dog did not see the mark but handled into the area and picked.

Test 3 judged by Steve Crooks

This was a static exercise. We stood in our allocated positions as the judge explained the exercise. There would be 3 marks, Dog A to pick on the right, Dog B to pick in the middle & Dog C to pick on the left. Once picked these would be replaced and the dogs would be sent to another location to pick a blind replacement (e.g. Dog A to pick from the area dog B had the original mark). Dog A was sent for the 1st mark and went straight to the fall and picked. Dog B was sent for the 2nd mark and went straight to the fall and picked. Dog C was sent to the left, some handling required but quickly picked. The second retrieve of the test Dog A was sent blind to the middle, the dog took a good line, stopped on the whistle and hunted to the left and picked. Dog B was sent blind to the left, this took a little bit more effort to handle the dog into the area but was soon picked. Dog C was sent to the right and picked straight away with no handling required.

Test 4 judged by Tim Brain

This was a static water exercise. We stood in our allocated positions as the judge explained the exercise. Dog A had to pick a long mark straight out in front on the water. Dog B had to pick a blind across the water to the right. Dog C had to pick a mark across the water to the left. We could pick these retrieves in any order and if all 3 dogs were in the water at the same time we would gain 20 bonus points, we had 30 seconds to decide our tactics. Unfortunately, things didn't go quite to plan. Dog B was sent first for the blind; however, he refused to enter the water and was quickly called up. Dog A was then sent out for the long mark. He had been showing signs of an upset stomach before the test and unfortunately left the water for the inevitable to happen resulting in him being called up. Dog C was not offered the opportunity to pick.

Test 5 judged by Steve Richardson

This was a static exercise. We stood in our allocated positions as the judge explained the exercise. The would be a delayed mark to the right for Dog B. The would be a shot in front where dog A would be sent for a delayed blind. Dog C would have a straight mark to the left. Dog C was sent and picked relatively quickly with a small amount of handler input. Dog A was sent out for the blind, due to the thick cover the dog was out of sight almost instantly. Once he re appeared he was pushed right-handed into the area, he quickly picked but, on his return, we were all surprised to see that he'd picked a pigeon. No bonus points unfortunately! Dog A was then sent back for the dummy which he very quickly returned with. Dog B was the sent for the delayed mark which he picked with ease.

It was not a day for awards but the team thoroughly enjoy the event. Huge thanks to Steward North and his amazing team for a brilliantly run day. Congratulations to Midland Gundog who won and will be hosting the event in 2026.

I was asked to do a write up for the Southern Inter club event, this was a great opportunity to appreciate the ups and down, snake and ladders of gundog events.



This was Simon's first team event and both him and Star handled it really well. The ground at Issenhurst is amazing, with all types of cover, water and lots of bunkers. We had five really well thought out tests.

Our first test was two marks over a ditch off to the right, followed by a tricky mark to the front. We all did really well here which was a relief as we were all quite nervous.

Second test was a mark into water for ndnh, a mark across the water for the novice. When the novice dog was on its way back there was a shot for the blind on further along the bank for the open dog, which acted as a distraction for the novice dog. We all executed our retrieves well on this test.

Third test was a shot to honour a blind and then 2 very tricky marks. The first you couldn't really see the fall and the second mark into a pond behind us and was obscured by a tree. Not so good here as one of the front retrieves was picked in wrong order.

Fourth test was a walk up, 3 retrieves in different areas, followed by another 3 blinds. One very important note of the day, we had a joker to play which means you can double your points, we decided not to use it this time but wish we had as we had top marks on this one.

Well, so far we were doing really well and were beginning to think we were in for a chance of a placing.

Fifth test. Long mark out on a pond, followed by a mark on a strip of ground off to the right but had to swim to it, followed by a shot up in the wood for a blind. Oh yes and we had played our joker, hoping to double our points! Sadly Simon didn't make it to his, followed by Lesley not picking hers, oh no... followed by me not picking mine! Poor Simon was pretty disappointed, however Lesley and I took it in good humour and burst out laughing as we were so shocked. Then we realised not only had we got 3 0's but we had played our joker so we got 6 0's. So sorry Kennet Valley to disappoint as up until then we were doing really well. The peaks and troughs of gundogs. We had a brilliant day, thank you for the invite. Bit like my school report, next time we will all try harder!
